WHEREAS Article 6, § 20 of the Arizona Constitution and Supreme Court Administrative Order No. 2001-62 issued on June 20, 2001, authorizes presiding judges to temporarily call back to active duty retired judges, listed as qualified by the Administrative Director of the Arizona Supreme Court, to serve as a judge of the Superior Court,
