ADMINISTRATIVE ORDER
NO. 2012-129

WHEREAS, A.R.S. § 22-601(A) authorizes the Presiding Judge of the Superior Court to establish a homeless court to adjudicate cases filed in a Justice of the Peace Court or a municipal court in a county; and

WHEREAS, Superior Court Administrative Order No. 2012-128 creates a Maricopa County Regional Homeless Court (“MCRHC”) Governing Council to manage the day-to-day operations of the MCRHC, and to make further recommendations for operation of the MCRHC and modifications of eligibility criteria to the Maricopa County Superior Court Presiding Judge in accordance with A.R.S. § 22-601;

WHEREAS, Superior Court Administrative Order No. 2012-128 provides for the Maricopa County Regional Homeless Court Governing Council to consist of a total of six (6) members comprised of three (3) Justices of the Peace designated by the Justice of the Peace Presiding Judge, a City of Phoenix Municipal Court judge designated by the Presiding Judge of the City of Phoenix Municipal Court, and two (2) municipal court Presiding Judges; and

WHEREAS, the Maricopa County Justice of the Peace Presiding Judge and the Presiding Judge of the City of Phoenix Municipal Court have each designated their members of the Council, and the remaining municipal court judge members having been elected by a majority of municipal court Presiding Judges present at a regularly scheduled Maricopa County lower court jurisdiction Presiding Judges meeting with an agenda distributed prior to the meeting indicating that the election will occur; and

WHEREAS, pursuant to Superior Court Administrative Order No. 2012-128, the Maricopa County Superior Court Presiding Judge designates a member of the Maricopa County Regional Homeless Court Governing Council to be the MCRHC Presiding Judge.

IT IS ORDERED appointing the following members of the Maricopa County Regional Homeless Court Governing Council effective upon signature of this Order and continuing for a two-year term ending on the expiration date listed, or until a successor is duly appointed, whichever shall last occur:
